# August 15th Board Chapel

What a truly uplifting sermon we had at our Board Chapel, delivered by Ken Denslow, President of the



Lake Union Conference. His message, centered on the powerful chapter of Hebrews 11, often referred to as the "Hall of Faith", highlighted the unwavering faith of those who came before us, serving as a timeless reminder of the steadfast trust in God that these biblical

figures exhibited, even in the face of uncertainty and trials. Elder Denslow emphasized several key steps of faith as exemplified in Hebrews 11:



- Hearing God's Call: The heroes of faith were first and foremost listeners to God's call. Whether it was Abraham being called to leave his homeland or Noah being instructed to build the ark, each person was attentive and responsive to God's voice.
- Believing in God's Promise: These figures placed their trust in God's promises, even when the outcome was not visible. Their belief wasn't merely intellectual but

was rooted in a profound trust in God's faithfulness, compelling them to act.

- 3. **Obeying God's Command:** Their faith was made evident through action. They didn't just believe—they followed through with obedience, even when it required significant sacrifice.
- 4. **Persevering Through Challenges:** Faith also meant enduring through difficulties. Despite facing trials and hardships, they continued to persevere in faith, securing their place in the "Hall of Faith."

Elder Denslow's message reminded us that these steps are not just for the people of the Bible but are relevant to our lives today. As we encounter our own uncertainties and trials, we can follow these same steps, recognizing that faith is an active, enduring trust in God. This trust transforms hearing into believing, believing into obeying, and obeying into persevering.

Jesus is coming soon. Let us keep this hope alive so that our names will remain in the Book of Life,

alongside the faithful who have gone before us. May we live each day with unwavering trust in His promises, persevering through



trials, and obediently following His call, so that when He returns, we will be found faithful and ready to meet Him.

# HR News . . .

This year's open enrollment will be September 23<sup>rd</sup> – October 15<sup>th</sup>. Over the next few weeks, we will be sharing more information as we get closer to open enrollment.

If you work 30+ hours per week and you have opted to be part of PPPA healthcare you would be eligible for a Flexible Spending Acct. What is an FSA acct. and why might you consider one? An FSA is an employer-sponsored arrangement that allows employees to use pre-tax money to pay for medical and dependent care expenses for you, your spouse and your dependents. Some of the benefits include:

Tax savings- employees can save money on income taxes by setting aside money before taxes are deducted.

Management of Out of Pocket medical costsemployees can use FSA funds to pay for expenses that aren't covered by health insurance.

The IRS determines what is considered an eligible expense. Some examples of eligible expenses include:

- Deductibles and co-pays
- Medical office visits
- Prescription medications
- Over-the-counter medicines with a doctor's prescription
- Insulin

- Medical equipment like crutches
- Supplies like bandages
- Diagnostic devices like blood sugar test kits
- Therapy and counseling services
- Oral care

#### How it works:

Each pay period, a regular portion of your FSA election will be deducted tax-free from your biweekly paycheck. These deductions are taken from your gross pay before your federal, state, social security and income taxes are withheld. The deductions are then contributed to your FSA for your use on eliqible expenses

Once you are enrolled, you can access your funds to pay for eligible expenses.

If you already have an FSA there is an IRS carryover limit of \$640 from 2024-2025. Employees can also file a claim for expenses incurred from 2024 until March 31, 2025.
